Dear Township Committee,

At the request of CFO, Lenard Ho, I am writing to inform you on two (2) grants.

The first is a NJDOT grant in the amount of \$186,000. The plans are being prepared now and it is expected that bids will be received in April or May. A preliminary estimate shows that there are sufficient funds in the grant for construction, engineering and testing. Therefore, at this time, no Township funds will be needed. I recommend the grant be included in the Township's 2024 budget as soon as possible.

The second grant is from the NJDEP in the amount of \$25,000 to digitize the mandated stormwater map. I anticipate the map should be completed within the grant amount by this summer. The grant should be included in the 2024 budget.
