TOWNSHIP OF WINFIELD –ORD. # 313

AN ORDINANCE TO AMEND AN ORDINANCE 313 ENTITLED "AN ORDINANCE TO REGULATE COMMERCIAL REGISTERED VEHICLES UPON THE STREETS OF THE TOWNSHIP OF WINFIELD, NEW JERSEY."

BE IT ORDAINED, by the Township Committee of the Township of Winfield, County of Union, State of New Jersey, that

WHEREAS, the Township Committee desires change the regulation of the parking of commercial vehicles in Winfield.

NOW, THEREFORE, BE IT ORDAINED by the Township Committee of the Township of Winfield, County of Union, State of New Jersey, as follows:

SECTION 1. Section 1 of Ordinance No. 313 is hereby amended as follows:

a. Definitions

Commercial vehicle includes, but is not limited to, vehicles with the following types of registrations: commercial, contractor or bus; any vehicle containing advertising intended to promote the interest of any business, or any vehicle containing advertising intended to promote the interest of any business as a commercial vehicle with the New Jersey State Division of Motor Vehicles.

The remaining provisions of this Section remain unchanged.

SECTION 2. Section 2 of Ordinance No. 313 is hereby amended as follows:

Exceptions. The parking restriction shall not apply to any commercial registered vehicle of a public utility company, commercially registered rental, leased and auto dealership loaner passenger vehicles, and state registered Winfield Board of Education School Buses. The parking restriction shall not apply to any commercial vehicle while it is being used in the transaction of business with the owner or occupant of a residential property.

SECTION 3. No change.

SECTION 4. If any portion of this ordinance shall be determined to be invalid, such determination shall not affect the validity of the remaining portions of said ordinance. SECTION 5. This ordinance shall take effect twenty days after final passage and publication in accordance with law.
