Public Comments:

Trish Donahue, 32 Riverview- asked if the ordinance could be explained; where is the restricted area; who would be allowed to go in and out & where is the area – where was the restricted area prior. Mayor Koomer responded- Information in the office, limits outside public who cannot view personal records – ordinance to keep items already located in twp office safeguarded. Commissioner Byrne replied, if anyone ended up back with files that shouldn't be there, could be a recourse.

Chief Dustin – asked if it relates to him; Clerk Slowik - it allows for all department heads accessibility.

No further members of the public wished to speak. Mayor Koomer closed the floor to public discussion.

A motion to take up the Ordinance for adoption was made by Commissioner Byrne and Seconded by Commissioner Reilly, with all members present voting in the affirmative.

**TOWNSHIP OF WINFIELD - # 461
COUNTY OF UNION, STATE OF NEW JERSEY
AN ORDINANCE ESTABLISHING RESTRICTED AREAS IN BUILDINGS WHERE MUNICIPAL
OPERATIONS ARE CONDUCTED LIMITED TO AUTHORIZED EMPLOYEES TO PROTECT AND
SAFEGUARD PUBLIC RECORDS CONTAINING PERSONALLY IDENTIFIABLE INFORMATION**

WHEREAS, the Township of Winfield officials and employees have a responsibility to maintain and safeguard public records that consist of confidential information; and

WHEREAS, to adequately comply with the New Jersey Open Public Records Act, N.J.S.A. 47:1A-1, and comply with the statutorily defined responsibilities, the maintenance and custody of specific records are required; and

WHEREAS, municipal officials assigned this responsibility include, but are not limited to; the Municipal Clerk, the Police Chief, the Chief Financial Officer, the Tax Collector, the Tax Assessor, the Construction Code Officer. and the Board of Health Secretary; and

WHEREAS, the responsibility for the maintenance and safeguarding of records, reports, documents and information in municipal offices may not be available for immediate public view since they may contain personal information, phone numbers, social security numbers, dates of birth and other confidential information; and

WHEREAS, securing these records maintains the integrity of this information and when an OPRA request is received, and it is determined that a requestor is entitled to the record(s), the record(s) can be released individually and redacted as required by law; and

WHEREAS, securing and keeping these records confidential will support a safe workplace while balancing public access to the Township Building; and

WHEREAS, the Township cannot expect municipal employees to physically intervene to protect a record, or other Township assets or personal belongings, and creating secure areas with clear signage will help deter persons from collecting records that they are not entitled to receive without following the process required by OPRA; and

NOW, THEREFORE, BE IT RESOLVED, by the Township Committee of the Township of Winfield as follows:

Section 1. The Township of Winfield shall be required to post signs outside of offices which read, "Restricted Area, Authorized Employees Only".

Section 2. Persons that trespass these posted, protected offices may be subject to prosecution under N.J.S.A. 2C-18-3.

Section 3. This ordinance shall become effective twenty (20) days after final passage and advertisement thereof as required by law.

WHEREAS, as part of its comprehensive efforts to improve water quality and migrate the working impacts of flooding caused by climate change, the New Jersey Department of Environmental Protection wishes to modernize stormwater management systems, that will focus on strategies to better manage the impacts of stormwater; and

WHEREAS, the Department of Environmental Protection has allotted \$25,000 in funding available for each Tier A municipality to help assist with a Stormwater Infrastructure Map; and

WHEREAS, the Township of Winfield is desirous to make an application provided by the Department of Environment Protection; and

BE IT RESOLVED, that the Mayor/Township Clerk/Township Engineer is hereby authorized to:

- (a) Make application for such grant through DEP System
- (b) Submit necessary documentation
- (c) Provide additional application information and furnish such documents as may be required, and

WHEREAS, this MOU is intended to memorialize the relationship and delineate the responsibilities of the Parties in this cooperative joint effort; and

WHEREAS, law enforcement officers may request the assistance of mental health specialists when responding to emergency service calls that relate to behavioral health crises and mental health personnel may request assistance from officers when responding to requests for emergency screenings; and

WHEREAS, the Parties agree that in the performance of the MOU and the Program, they will comply will all applicable federal, State, and local laws, statutes, and regulations, including all requirements of the Screening Law and Regulations and the Health Insurance Portability and Accountability Act of 1996 (HIPAA); and

WHEREAS, Addendum Two was created to amend the existing Agreement and supplement Addendum One to include additional municipalities as participants in the pilot program as permitted by Paragraph 17 of that Agreement; and

WHEREAS, the Winfield Police Department is desirous of participating in the program pilot; and

➤ **WVFD Volunteer Prospective Discussion**

Chief Dustin said candidate was on his way, sent him a text message. Mayor Koomer stated we will come back prior to end of meeting. Candidate showed up just before going to public forum. Vincent Cannady – trying to be a Fireman & EMT. Twp has questions about the background check. PD did not recommend. Mayor Koomer, we passed an ordinance that relates to not accepting a candidate that the PD doesn’t recommend. Chief Dustin stated he wanted to talk to Committee – case happened so long ago, was never found guilty, and what it was would be legal now. Township attorney will take a look into the ordinance. Candidate offered to get additional information from his attorney if needed.

CITIZEN’S FORUM:

(Trish Donahue) (Housing Manager) – Would like to know about Shared Services, and what have we done to cut back on cost services on SSA. What are costs and savings? (Mayor Koomer) we will research agreements. We have BOH – (Attorney Colicchio) suggested to do an OPRA request to be better served. (Ms. Donahue) no problem to complete. (Mayor Koomer) we are always looking for other ways to save money – have found other avenues that were more expensive. (Ms. Donahue) aske about cost savings to merge with courts – why are we outsourcing when the court doesn’t want to handle certain cases. Why are we shifting to different townships. Does not help community when the cases are outsourced and why that happens. It does not benefit the community. (Attorney Colicchio) asked for further details on if a conflict with Judge, would need more details. The judiciary is independent from oversight of the mayor and committee. If they recluse themselves or not, it is entirely up to the judge.

- Time went over the 5 minutes, discussion was ended

(Trish Donahue) (resident) - Who is responsible for roads, sidewalks, etc. if township is going to continue then we (WMHC) want to take everything back and under that. You cannot do roads and if there is a defect, why would you bring in engineer and consultant to do roads; WMHC does not have a line item for, who will be responsible, because she will bring to the membership meeting in November. (Mayor Koomer) we are not pushing back, was told it was a pot hole. We were not aware it was a sinkhole. Once we found out it was a sinkhole, we let WMHC know. Agreement states that Housing is responsible and lists the details. Twp sent a copy of the agreement. Ordinance was sent back to us. Consulted with attorney and responded to it. Simple agreement with WMHC and Twp, - it is MH responsibility. Ordinance states same. We do have the agreement. (Ms. Donahue) What about dedication? (Attorney Colicchio) Mayor gave the position of the TWP. Made a comment, asked a question, was responded to. Possibly further meetings to be had. But this is the Township's position.

- Time has reached 5 minutes

(John Diorio)(resident/WMHC Board Member) – Has there ever been any resolution or ordinance to overturn agreement? Has ever been a time when TWP paves road? (Mayor Koomer) there has been no change. It stands. No agreement between the two that would affect this agreement. (Commissioner Reilly) Grant from State of NJ for road repairs is applied for by Twp. No line item in budget for road services or repairs. (Mr. Diorio) If something happens to the road tomorrow, a big truck tears up road. (Commissioner Reilly) Twp cannot repair – what would cause him to tear up road? We do not have a budget for roads. This would then be an insurance matter on the person who destroys road.

(Chief Dustin)- Can we allow any longer than 5 minutes? (Attorney Colicchio) 5 minutes is what time frame is allowed for Winfield Twp.

(Robin Kluse)(resident)- People from Pacific received a letter about garbage. Have several neighbors that leave garbage out on the curb without a can. Why were they singled out. (Commissioner Reilly) we received numerous complaints on that street. We did not target entire town, sent a letter for units in that area telling people to use garbage can.
