



**TOWNSHIP OF WINFIELD RESOLUTION 21-08
 COUNTY OF UNION, STATE OF NEW JERSEY
 AUTHORIZING BUDGET APPROPRIATIONS TRANSFER #1**

WHEREAS, it shall become necessary to extend from some of the purposes specified in the budget in excess of the respective sums appropriated; and

WHEREAS, there is an excess in one or more appropriations over and above the amount deemed necessary to fulfill the purpose of the 2020 appropriations; and

WHEREAS, NJSA 40A:4-58 provides that the transfer of such amounts of which are deemed in excess to the 2020 appropriations the amounts of which are deemed to be insufficient to fulfill the purposes of such 2020 appropriations; and

WHEREAS, the transfer to be authorized does not affect any 2020 appropriations to which or from transfers are prohibited under the statutes.

NOW THEREFORE BE IT RESOLVED, that the following transfers between appropriations be authorized pursuant to NJSA 40A4-58:



