AN ORDINANCE FIXING SALARIES OF CERTAIN OFFICIALS AND EMPLOYEES OF THE TOWNSHIP OF WINFIELD.

BE IT ORDAINED BY THE TOWNSHIP OF WINFIELD, IN THE COUNTY OF UNION:

Section 1: The salaries of all officials and employees of the Township of Winfield hereinafter designated are hereby established and fixed in and at the amounts indicated for the year 1972:

- (a) Secretary to the Township Committee and Deputy Clerk of the Township \$6,400.00 per annum, payable semi-monthly.
- (b) Assessor of the Township of Winfield \$150.00 per annum, payable annually.
- (c) Treasurer of the Township of Winfield \$700.00 per annum, payable monthly.
- (d) Clerk of the Township of Winfield \$700.00 per annum, payable monthly.
- (ê) Collector of Taxes of the Township of Winfield \$100.00 per annum, payable annually.
 - (f) Township Attorney \$1,800.00 per annum, payable quarterly.
- (g) Clerk of the Municipal Court of the Township of Winfield \$700.00 per annum, payable monthly.
 - (h) Township Engineer \$400.00 per annum, payable annually.
 - (i) Township Magistrate \$1,200.00 per annum, payable monthly.
- (j) Township Caretaker \$2,120.00 per annum, payable semi-monthly.
- (k) Welfare Director of the Township of Winfield \$700.00 per annum, payable monthly.
- (1) Plumbing Inspector of the Township of Winfield \$150.00 per annum, payable annually.
- (m) Superintendent of Public Works of the Township of Winfield \$300.00 per annum, payable annually.
- (n) Director of Civil Defense of the Township of Winfield \$200.00 per annum, payable annually.
- (0) Municipal Prosecutor of the Township of Winfield #400.00 per annum, payable quarterly.
- (p) Health Officer of the Township of Winfield \$1,250.00 per annum, payable quarterly.

Section 2: All ordinances or parts of ordinances inconsistent herewith are hereby repealed as to such inconsistent parts or provisions.

Section 3: This ordinance shall take effect immediately after publication in a manner provided by law, retroactive to January 1,1972.
