

AN ORDINANCE FIXING SALARIES OF  
CERTAIN OFFICIALS AND EMPLOYEES  
OF THE TOWNSHIP OF WINFIELD

BE IT ORDAINED BY THE TOWNSHIP OF WINFIELD, IN THE COUNTY OF  
UNION:

Section 1: The salaries of all officials and employees of the Township of Winfield hereinafter designated are hereby established and fixed in and at the amounts indicated for the year 1973:

(a) Secretary to the Township Committee and Deputy Clerk of the Township - \$6,800.00 per annum, payable semi-monthly.

(b) Assessor of the Township of Winfield - \$150.00 per annum, Payable annually.

(c) Treasurer of the Township of Winfield - \$700.00 per annum, payable monthly.

(d) Clerk of the Township of Winfield - \$700.00 per annum, payable monthly.

(e) Collector of Taxes of the Township of Winfield - \$100.00 per annum, payable annually.

(f) Township Attorney - \$2,300 per annum, payable quarterly.

(g) Clerk of the Municipal Court of the Township of Winfield - \$700.00 per annum, payable monthly.

(h) Township Engineer - \$400 per annum, payable annually.

(i) Township Magistrate - \$1,200.00 per annum, payable monthly.

(j) Township Caretaker - \$2,100.00 per annum, payable semi-monthly.

(k) Welfare Director of the Township of Winfield - \$700.00 per annum, payable monthly.

(l) Plumbing Inspector of the Township of Winfield - \$150.00 per annum, payable annually.

(m) Superintendent of Public Works of the Township of Winfield - \$300.00 per annum, payable annually.


(n) Director of Civil Defense for the Township of Winfield - \$200.00 per annum, payable annually.

(o) Municipal Prosecutor of the Township of Winfield - \$400.00 per annum, payable quarterly.

(p) Executive Officer - \$1,250.00 per annum, payable quarterly


Section 2: All ordinances or parts of ordinances inconsistent herewith are hereby repealed as to such inconsistent parts of provisions.

Section 3: This ordinance shall take effect immediately after publication in a manner provided by law, retroactive to January 1, 1973.
