

AN ORDINANCE AUTHORIZING THE CONSTRUCTION  
AND RECONSTRUCTION OF CURBS AND PAVING OF  
CERTAIN STREETS IN THE TOWNSHIP OF WINFIELD  
AND TO PROVIDE FUNDS TO FINANCE THE COSTS  
THEREOF.

BE IT ORDAINED BY THE TOWNSHIP COMMITTEE OF THE TOWNSHIP OF WINFIELD,  
in the County of Union as follows:

SECTION 1. That certain sections of curbs along the following  
streets be constructed or reconstructed: Gulfstream Avenue and Pacific  
Drive, and that Gulfstream Avenue and Pacific Drive be repaved.

SECTION 2. That all of the foregoing work will be done by contract  
under the supervision and direction of the Township Engineer.

SECTION 3. There is hereby appropriated for the purpose of the  
aforesaid improvement the sum of \$33,000.00.

SECTION 4. The cost of aforesaid improvement shall be financed in  
the following manner:

B. Appropriation from the Capital Improvement Fund 22,696.58

SECTION 5. It is hereby determined and stated that the making of the  
improvement set forth in Section 1 is a General Capital Improvement and no  
part of the cost of said improvement shall be assessed against the property  
specially benefited.

SECTION 6. This Ordinance shall take effect after final passage in  
the manner provided by law.

at a special meeting of the Township Committee of the Township of Winfield  
in the County of Union on April 22, 1974, and was adopted on final reading
