

AN ORDINANCE TO AMEND AN ORDINANCE ENTITLED
"AN ODINANCE AUTHORIZING THE CONSTRUCTION
AND RECONSTRUCTION OF CURBS AND PAVING CERTAIN
STREETS WITHIN THE TOWNSHIP OF WINFIELD IN THE
COUNTY OF UNION AND TO PROVIDE THE FUNDS TO
FINANCE THE COSTS THEREOF," ADOPTED MAY 2, 1974
IDENTIFIED AS ORDINANCE 159.

BE IT ORDAINED BY THE TOWNSHIP COMMITTEE OF THE TOWNSHIP
OF WINFIELD, in the County of Union as follows:

SECTION 1. Section 1 of Said Ordinance is amended to read
that certain sections of curbs along the following streets be constructed
and reconstructed: Gulfstream and Pacific Drive, and that Gulfstream and
Pacific Drive be repaved.

SECTION 2. That Section 3 of Said Ordinance is amended to
increase the amount appropriated by \$5,584.00 from \$33,000.00 to \$33,584.00
