AN ORDINANCE CREATING THE POSITION OF PUBLIC HEALTH NURSE DEFINING THE DUTIES AND QUALIFICATIONS THEREOF IN THE TOWNSHIP OF WINFIELD, COUNTY OF UNION AND STATE OF NEW JERSEY

BE IT ORDAINED by the Board of Health of the Township of WInfield, in the County of Union that:

### Section 1.

There is hereby created the position of Public Health Nurse in and for the Township of Winfield, County of Union and State of New Jersey.

# Section 2.

In order to qualify for the appointment to said office, applicant must:

- (a) Be a graduate from a school of nursing which meets the minimum requirements set by the State of New Jersey and working toward completion of thiry hours of academic credit in an approved program of study in public health nursing at a school of public health nursing accredited by the National Organization of public health nursing.
  - (b) Registration as a nurse in the State of New Jersey.
- (c) A minimum of ten years generalized experience in profession-
- (d) Ability to analyze, comprehend, interpret and apply the theory principles, practices and techniques of modern public health nursing.

#### Section 3

The duties of the person appointed to such office shall be as follows:

(a) Work with or by direction of the Health Officer or Executive Officer, plan and implement the approved public health nursing service resulting from a study and understanding of the needs of the community,; Said person is responsible for the proper implementation of the policies, rules, regulations and procedures as required by the administrative authority and performs related duties as required by the administrative authority.

- (b) Organizes field and office work and develops effective work methods; Prepares and conducts Child Health Conferences; Organizes and conducts Pre-school Hearing and vision Screening Sessions, Maternal and Child Health visits; Adult Health Supervision visits; Mental Illness and Mental Retardation visits; Provide Preventive Health Services and Clinics and other Health Department Programs as may be required.
- (c) Maintains a close harmonious liason with related professionals and agencies in order to provide for expedient handling of referred cases for: psychological testing, medical and surgical care for necessary cases, communicable diseases, Chronic illness, venereal diseases, tuberculosis, etc.
- (d) Evaluate the total program and suggest changes and additions for the improvement of services; and make reports and recommendations for improvements in performance; be responsible for the dissemination of all information necessary for education and public notices of all the responsible phases of the public health program; maintain a constant alertness for publication of new and important methods and procedures.

# Section 4

All Ordinances and all provisions of Ordinances inconsistent with the provisions of this Ordinance be and the same are hereby repealed to the extent of such inconsistency.

## Section 5.

This Ordinance shall become effective immediately upon final adoption and publication thereof according to law.
