AN ORDINANCE ESTABLISHING AND REGULATING  
A SPECIAL POLICE DEPARTMENT IN THE TOWNSHIP  
OF WINFIELD IN THE COUNTY OF UNION

BE IT ORDAINED by the Township Committee of the Township of Winfield in the County of Union and the State of New Jersey as follows:

Section 1.

There is hereby established a Special Police Department in the Township of Winfield in the County of Union.

Section 2.

The governing body of the Township of Winfield in the County of Union may appoint such special policemen as in its discretion may be required at the annual organization meeting of such body or at any other meeting during the year and such appointments shall continue unless sooner revoked until January 1st of the following year. The governing body may revoke such appointments without cause or hearing.

Section 3.

Supervision and control of such Special Police Department shall be vested in the Chief of the regular police department.

Section 4.

Before any such special policemen are appointed, the Chief of Police shall ascertain whether the applicant for such appointment is eligible and qualified as provided for in the Revised Statutes of the State of New Jersey 40:47-19. The Chief of Police shall report on the eligibility of any such applicant for such an appointment to the governing body.

Section 5.

Special Policemen shall not be members of the regular Police Department, and their powers, rights and duties shall immediately cease

at the expiration of the term for which they were appointed, or upon revocation of their appointment or on the removal of the cause or purpose for which they were appointed. they may be furnished with a badge or other Police equipment upon depositing the sum of \$50.00 which may be refunded on the return of the badge or other equipment.

#### Section 6.

No person shall be appointed as such special Policemen unless he is a citizen of the United States and is able to read, write and and speak the English Language, be at least eighteen (18) years of age, physically qualified and be of good moral character. He shall not have been convicted of any crime, and shall comply with all the other qualifications and requirements for appointment as set forth in the revised Statutes of New Jersey 40:47-19.

#### Section 7.

No special Policemen shall carry a revolver or other weapon or other police designation of authority when off duty.

#### Section 8.

Every special policemen shall be fingerprinted and his fingerprints shall be filed with the division of State Police and the Federal Bureau of Investigation.

#### Section 9.

Every such member of said special police department shall comply with the rules and regulations governing the conduct and decorum of the members of the regular police department.

#### Section 10.

Appointment as a special policeman will not be construed to constitute the special policeman a member of the regular police department. During the term of his appointment, however, he will possess such authority as is possessed by members of the regular police department as far as duty and right to arrest are concerned.

#### Section 11.

The ranks in the special police department shall be as follows: Captain, Lieutenant, Sergeant, Patrolman.

#### Section 12.

Captains shall be under the direct control of the Chief of Police and subject to all his orders at all times. He shall see that proper records are kept. He shall be responsible for the supervision and control of the members, and for the execution of all laws and ordinances and the rules and regulations. He shall constantly check on his supervisory officers

to see that they are carrying out his orders and obtaining satisfactory results.

Section 13.

Lieutenents shall be under the direct control of the Captain. In the absence of the Captain, the Lieutenant shall assume the duties and responsibilities of the Captain.

Section 14.

Sergeants will perform the duties that may be prescribed by the Captain or Lieutenant. Sergeants will make sure that each member understands his duties. He shall call the attention of his Captain or Lieutenant to all matters of importance such as unusual occurrence, or conditions requiring them to be informed.

Section 15.

Patrolman shall be assigned duties by the sergeant. They shall be held strictly accountable for the good order of the beat or post to which they have been assigned.

Section 16.

Special Policeman shall be responsible for the good care, proper maintenance and serviceable condition of department property issued for, or assigned to their use. Every special policeman shall promptly report to his immediate officer the loss of, damage to, or unserviceable condition of any department property issued for, or assigned to his use.

Section 17.

Every such special policeman shall perform his duties only in the municipality wherein he is appointed, Except when in fresh pursuit of any person pursuant to the revised Statutes of the State of New Jersey 40:47-19.

Section 18.

Members of such special police department while on active duty, shall bear an official insignia or badge of authority indicating their membership in the department.

Section 19.

The members of the Special Police Department shall be subject to such rules and regulations as may be promulgated from time to time by the Township Committee.

This ordinance shall take effect immediately after publication in the manner provided by law.
