

AN ORDINANCE FIXING SALARIES OF
CERTAIN OFFICIALS AND EMPLOYEES
OF THE TOWNSHIP OF WINFIELD

BE IT ORDAINED BY THE TOWNSHIP OF WINFIELD, IN THE
COUNTY OF UNION:

Section 1. The salaries of all officials and employees of the Township of Winfield hereinafter designated are hereby established and fixed in and at the amounts indicated for the year 1976.

(a) Secretary to the Township Committee and Deputy Clerk of the Township- \$7,800.00 per annum, payable semi-monthly.

(b) Assessor of the Township of Winfield- \$150.00 per annum, payable annually.

(c) Treasurer of the Township of Winfield- \$700.00 per annum, payable monthly.

(d) Clerk of the Township of Winfield- \$700.00 per annum, payable monthly.

(e) Collector of Taxes of the Township of Winfield- \$100.00 per annum, payable annually.

(f) Township Attorney- \$3,450.00 per annum, payable quarterly.

(g) Clerk of the Municipal Court of the Township of Winfield- \$350.00 per annum, payable monthly.

(h) Deputy Clerk of the Municipal Court of the Township of Winfield- \$350.00 per annum, payable monthly.

(i) Township Engineer- \$500.00 per annum, payable annually.

(j) Township Magistrate- 1,200.00 per annum, payable monthly.

(k) Township Caretaker- \$2,400.00 per annum, payable semi-monthly.

(l) Welfare Director of the Township of Winfield- \$700.00 per annum payable monthly.

(m) Plumbing Inspector of the Township of Winfield- \$150.00 per annum, payable annually.

(n) Superintendent of Public Works of the Township of Winfield- \$300.00 per annum, payable annually.

(o) Director of Civil Defense of the Township of Winfield- \$200.00 per annum, payable annually.

(p) Municipal Prosecutor of the Township of Winfield- \$500.00 per annum, payable quarterly.

(q) Executive Officer of the Board of Health- \$1,400.00 per annum, payable quarterly.

(r) Public Health Nurse- \$5.85 per hour- payable semi-monthly.

Section 2: All ordinances or parts of ordinances inconsistent herewith are hereby repealed as to such inconsistent parts or provisions.

Section 3: This ordinance shall take effect immediately after publication in a manner provided by law, retroactive to January 1, 1976.
