AN ORDINANCE TO PROHIBIT THE POSSESSION
OR DRINKING OF ALCOHOLIC BEVERAGES IN
PUBLIC PLACES IN THE TOWNSHIP OF WIN-
FIELD, IN THE COUNTY OF UNION

BE IT ORDAINED by the Township Committee of the Township of Winfield in the County of Union.

Section 1. No person shall place, carry or have in his possession in a public place as hereinafter defined, any alcoholic beverage as the same is defined in the Alcoholic Beverage Control Law of the State of New Jersey (N.J.S.A.33:1-1 for the purpose of drinking, imbibing or consuming the same therein, nor shall any person drink, imbibe or consume any such alcoholic beverage in any such public place.

Section 2. For the purpose of this ordinance, public place shall mean any park, recreational area, playground and properties owned by the Board of Education of the Township of Winfield, The Township of Winfield, The County of Union, The State of New Jersey, The United States government or any other building, grounds or area of public ownership.

Section 3. No person shall be drunk or in a state of intoxication in or upon any street, highway, thoroughfare or public place as hereinabove defined.

Section 4. The Chief of Police may issue special permits for certain designated public and or recreational areas authorizing the dispensing and consumption of alcoholic beverages during certain designated dates and times during the course of a picnic or other activity sponsored by nonprofit corporation or organization holding a permit for the use of said area during said date and time. Permits must be applied for at least 7 days prior to any activity or function.

Section 5. Any person violating any provision of this ordinance shall, upon conviction, be punished by a fine not exceeding \$500.00, or by imprisonment not exceeding ninety (90) days, or both, in the discretion of the Judge of the Municipal Court.

Section 6. All ordinances or parts of ordinances inconsistent herewith are hereby repealed to the extent of such inconsistency.

Section 7. If any section, subsection, sentence, clause, phrase or portion of this ordinance is for any reason adjudged to be invalid by a court of competent jurisdiction, such portion shall be deemed a separate, distinct and independent provision, and such adjudication shall not affect the validity of the remainder hereof.

Section 8. This ordinance shall take effect immediately after passage and publication in the manner provided by law.
