

AN ORDINANCE FIXING SALARIES OF CERTAIN OFFICIALS  
AND EMPLOYEES OF THE TOWNSHIP OF WINFIELD

BE IT ORDAINED BT THE TOWNSHIP OF WINFIELD, IN THE COUNTY OF UNION:

Section 1. The Salaries of all officials and employees of the Township of Winfield hereafter designated are hereby established and fixed in and at the amounts indicated for the year 1977.

- (a) The Township Commissioners-\$1.00 per annum, payable annually.
- (b) Secretary to the Township Committee and Deputy Clerk of the Township- \$8,190.00, payable semi-monthly.
- (c) Part-time Clerical services at \$3.40 per hour, payable semi-monthly.
- (d) Assessor of the Township of Winfield- \$150.00 per annum, payable annually.
- (e) Treasurer of the Township of Winfield- \$700.00 per annum, payable monthly.
- (f) Clerk of the Township of Winfield- \$700.00 per annum, payable monthly.
- (g) Collector of Taxes of the Township of Winfield- \$75.00 per annum, payable annually.
- (h) Township Attorney- \$3,625.00 per annum, payable quarterly.
- (i) Clerk of the Municipal Court of the Township of Winfield- \$700.00 per annum, payable monthly.
- (j) Deputy Clerk of the Township of Winfield Municipal Court- \$350.00 per annum, payable monthly.
- (k) Township Engineer- \$500.00 per annum, payable annually.
- (l) Township Inspector for Oil & Gas Burners- \$25.00 per annum, payable annually.
- (m) Township Magistrate- \$1,260.00 per annum, payable monthly.
- (n) Caretaker of the Township of Winfield- \$2,520.00, payable semi-monthly.
- (o) Welfare Director of the Township of Winfield- \$700.00 per annum payable monthly.
- (p) Plumbing Inspector of the Township of Winfield- \$150.00 per annum, payable annually.
- (q) Superintendent of Public Works- \$200.00 per annum, payable annually.

(r) Director of Civil Defense- \$150.00 per annum, payable annually.

(s) Municipal Prosecutor of the Township of Winfield- \$500.00 per annum, payable quarterly.

(t) Executive Officer of the Board of Health \$1,470.00 per annum, payable quarterly.

(u) Public Health Nurse- \$6,195.00 per annum, payable semi-monthly.

(v) Members of the board of Health shall receive \$2.00 per every meeting attended, payable annually.

Section 2: All ordinances or parts of ordinances inconsistent herewith are hereby repealed as to such inconsistent parts or provisions.

Section 3: This ordinance shall take effect immediately after publication a manner provided by law, retroactive to January 1, 1977.


