

AN ORDINANCE AUTHORIZING THE MAYOR AND
TOWNSHIP CLERK TO EXECUTE AN AGREEMENT WITH
UNION COUNTY FOR COOPERATIVE PARTICIPATION
IN THE COMMUNITY DEVELOPMENT REVENUE SHARING
PROGRAM PURSUANT TO THE INTERLOCAL SERVICES
ACT.

WHEREAS, certain Federal funds are potentially available to Union County under Title 1 of the Housing and Community Development Act of 1974, commonly known as Community Development Revenue Sharing; and

WHEREAS, it is necessary to establish a legal basis for the County and its people to benefit from this program; and

WHEREAS, an Agreement has been proposed under which the Township of Winfield and the County of Union in cooperation with other municipalities will establish an Interlocal Services Program pursuant to N.J.S.A. 40:8A-1; and

WHEREAS, it is in the best interest of the Township of Winfield to enter into such an agreement;

NOW THEREFORE, Be It Ordained by the Mayor and Township Clerk of the Township of Winfield, that the agreement entitled "Agreement Between the County of Union and certain municipalities located therein for the establishment of a cooperative means of conducting certain community development activities," a copy of which is attached hereto, be executed by the Mayor and Township Clerk in accordance with the provisions of law; and

Be It Further Ordained that this Ordinance shall take effect immediately upon its enactment.
