

AN ORDINANCE FIXING SALARIES OF CERTAIN OFFICIALS  
AND EMPLOYEES OF THE TOWNSHIP OF WINFIELD


BE IT ORDAINED BY THE TOWNSHIP OF WINFIELD IN THE COUNTY OF UNION:

Section 1. The salaries of all officials and employees of the Township of Winfield hereinafter designated are hereby established and fixed in the amounts indicated;


1. Township Commissioners-\$1.00 per annum, payable annually.
2. Township Clerk-\$500.00 payable semi-annually.
3. Deputy Township Clerk-\$550.00 per annum, payable quarterly.
4. Township Secretary-\$10,000.00 payable semi-monthly.
5. Part-time Clerical Services at \$3.65 per hour, payable semi-monthly.
6. Treasurer-\$700.00 per annum, payable semi-annually.
7. Township Tax Assessor-\$400.00 per annum, payable annually.
8. Township Tax Collector-\$150.00 per annum, payable annually.
9. Township Attorney-\$4550.00 per annum, payable quarterly.
10. Township Magistrate-\$1525.00 per annum, payable monthly.
11. Township Municipal Court Clerk-\$1800.00 per annum, payable semi-annually.
12. Municipal Prosecutor-\$500.00 per annum, payable quarterly.
13. Township Engineer-\$500.00 per annum, payable annually.
14. Township Caretaker-\$3035.00 per annum, payable semi-monthly.
15. Township Plumbing Inspector-\$150.00 per annum, payable annually.
16. Township Building Inspector-\$850.00 per annum, payable annually.
17. Township Fire Protection Official-\$150.00 per annum, payable annually.
18. Township Director of Civil Defence-\$150.00 per annum, payable semi-annually.
19. Superintendents of Public Works-\$200.00 per annum, payable annually.
20. Health Officer-\$250.00 per annum, payable annually.
21. Executive Health Officer-\$1780.00 per annum, payable quarterly.
22. Public Health Nurse-\$7672.00 per annum, payable semi-monthly.
23. Board of Health Members shall receive \$2.00 per every meeting attended, payable annually.
24. Township Welfare Director-\$750.00 payable monthly.
25. Police Chief-\$17700.00 payable semi-monthly.
26. Patrolmen-\$13425.00 payable semi-monthly.
27. Part-time Patrolmen-\$3.75 per hour, payable monthly.

Section 2. All ordinances or parts of ordinances inconsistent here with the hereby repealed as to such inconsistent parts or provisions.

Section 3. This ordinance shall take effect immediately after publication in a manner provided by law, retroactive to January 1, 1980.
