

AN ORDINANCE DESIGNATING CERTAIN LOCATIONS IN THE  
TOWNSHIP OF WINFIELD AS BUS STOPS IN ACCORDANCE  
WITH THE REQUIREMENTS OF THE N.J. TRANSIT CORPORATION

WHEREAS the County of Union has designated certain funds received from N.J. Transit Corporation to construct bus stops or shelters within the Township; and

WHEREAS the construction of the bus shelters will benefit many citizens of this Township; and

WHEREAS this Township Committee desires to conform to the Rules and Regulations of the N.J. Transit Corporation.

NOW THEREFORE BE IT ORDAINED BY THE TOWNSHIP COMMITTEE OF THE TOWNSHIP OF WINFIELD THAT the following described locations are hereby designated as Bus Stops:

1. A. Along Wavecrest Avenue northbound on the easterly side thereof at:
  - a. Seafoam Avenue (far side)  
Beginning at the northerly curblineline of Wavecrest Avenue and extending 110 feet northerly therefrom.
- B. Along Wavecrest Avenue southbound on the westerly side thereof at:
  - a. Riverview Terrace - (nearside)  
Beginning at the northerly curblineline of Riverview Terrace and extending 120 feet northerly thereof.
- C. Along Winfield Place, northbound on the easterly side thereof at:
  - a. Wavecrest Avenue - (far side)  
Beginning at the northerly curblineline of Wavecrest Avenue and extending 150 feet northerly therefrom.
2. This Ordinance will take effect as provided by law.
