

AN ORDINANCE AUTHORIZING THE TOWNSHIP COMMITTEE  
AND THE TOWNSHIP CLERK TO EXECUTE AN AGREEMENT  
WITH UNION COUNTY TO MODIFY THE INTERLOCAL  
SERVICES AGREEMENT DATED DECEMBER 1, 1979

WHEREAS, certain Federal Funds are potentially available to Union County under Title 1 of the Housing and Community Development Act of 1974, commonly known as Community Development Block Grants, and

WHEREAS, it is necessary to amend an existing interlocal services agreement for the County and its people to benefit from this program and

WHEREAS, an Agreement has been proposed under which the Township of Winfield and the County of Union, in cooperation with other municipalities will modify an Interlocal Services Program pursuant to N.J.S.A. 40:8A-1, and

WHEREAS, it is in the interest of the Township of Winfield to enter in to such an agreement,

NOW THEREFORE BE IT ORDAINED by the Mayor and the Township Committee of the Township of Winfield, that the Agreement entitled, "Agreement to Modify Interlocal Services Agreement dated December 1, 1979 for the Purpose of Inserting a Description of Activities for the 6th Year Urban County Community Development Block Grant Program," a copy of which is attached hereto, be executed by the Mayor and the Municipal Clerk in accordance with the provisions of Law, and

BE IT FURTHER ORDAINED THAT this Ordinance shall take effect immediately.


