- 7. Township Tax Assessor- \$450.00 per annum, payable annually.
- 8. Township Tax Collector \$200.00 per annum, payable annually.
- 9. Township Attorney \$4900.00 per annum, payable quarterly.
- 10. Township Magistrate \$2000.00 per annum, payable monthly &
- 11. Township Municipal Court Clerk-\$1340.00 per annum, payable quarterely
- 12. Municipal Prosecutor- \$500.00 per annum, payable quarterely.
- 13. Township Engineer \$750.00 per annum, payable annually.
- 14. Township Caretaker \$3250.00 per annum, payable semi-monthly.
