AN ORDINANCE FIXING SALARIES OF CERTAIN OFFICIALS AND EMPLOYEES OF THE TOWNSHIP OF WINFIELD FOR 1982

BE IT ORDAINED BY THE TOWNSHIP OF WINFIELD IN THE COUNTY OF UNION: Section 1. The salaries of all officials and employees of the Township of Winfield hereinafter designated are hereby established and fixed in the amounts indicated:

- 2. Township Clerk \$900.00 payable semi-annually.
- 3. Deputy Township Clerk \$700.00 per annum, payable quarterly.
- 4. Township Secretary \$12,000 payable semi-monthly.
- 5. Part time Clerical Services at \$4.50 per hour, payable monthly.
- 6. Treasurer \$1,500 per annum, payable quarterly.
- 7. Township Tax Assessor \$500.00 per annum, payable annually.
- 8. Township Tax Collector \$200.00 per annum, payable annually.
- 9. Township Attorney \$4,900.00 per annum, payable quarterly.
- 10. Township Magistrate \$2,400 per annum, payable monthly.
- 11. Township Municipal Court Clerk \$1,500.00 per annum, payable monthly.
- 12. Municipal Prosecutor \$500.00 per annum, payable quarterly.
- 13. Township Engineer \$750.00 per annum, payable annually.
- 14. Township Caretaker \$3,750.00 per annum, payable semi-monthly.
- 15. Township Plumbing Inspector \$350.00 per annum, payable annually.
- 16. Township Building Inspector \$950.00 per annum, payable annually.
- 17. Township Fire Protection Official \$200.00 per annum, payable annually.
- 18. Township Director of Civil Defense \$150.00 per annum, payable semi-annually.
- 19. Superintendent of Public Works \$225.00 per annum, payable annually.
- 20. Senior Citizen Coordinator \$200.00 per annum, payable annually.
- 21. Executive Health Officer \$2.200.00 per annum, payable quarterly.
- 22. Public Health Officer \$12,750.00 per annum, payable semi-monthly.
- 23. Board of Health Members shall receive \$2.00 per every meeting attended, payable annually.
- 24. Township Welfare Director \$1,000.00 per annum, payable monthly.
- 25. Part time Patrolmen \$4.50 per hour, payable monthly.

Section 2. All ordinances or parts of ordinances inconsistent here with are hereby repealed as to such incosistent parts or provisions.

Section 3. This ordinance shall take effect immediately after publication in a manner provided by law, retroactive to January 1, 1982.
