The County of Union, New Jersey proposes to use the \$5,164,000, Year IX Community Development Block Grant, plus \$236,000 reprogrammed unobligated funds from previous years, to provide decent housing, a suitable living environment, and expanding economic opportunity for all residents, but principally for those of low and moderate income.

In an effort to prevent deterioration of the county's housing stock, eliminate conditions detrimental to health, safety, and public welfare, encourage spatial deconcentration of lower income groups, and achieve a more rational use of land regarding residential and commercial centers, \$2,834,800 is proposed to be allocated to housing and commercial rehabilitation, as follows:
