

AN ORDINANCE TO AMEND AN ORDINANCE OF THE
TOWNSHIP OF WINFIELD, COUTY OF UNION,
STATE OF NEW JERSEY, AUTHORIZING THE
INCREASE OF 2.5% IN THE CAP LIMITATION
IN THE PREPARATION OF THE 1983 MUNICIPAL
BUDGET

WHEREAS, an ordinance authorizing the increase of 2.5% in the CAP limitation was adopted on March 21, 1983, and

WHEREAS, the figures included in such ordinance were inaccurate, and

WHEREAS, it is necessary to correct such items

NOW THEREFORE BE IT ORDAINED tha the following amendments be made:

Paragraph Five is amended to read:

WHEREAS, the Township Committee hereby determines that a 7.5% increase in the budget for said year, amounting to \$6,069.19 in excess of the increase in final appropriations permitted by a 5% CAP, is advisable and necessary, and

Paragraph Six is amended to read:

WHEREAS, this additional amount will be appropriated for the purposes set forth below, increasing the total appropriation for each such purpose from what would otherwise be provided under the limitations of a 5% CAP, as also set forth below:

POLICE - Salaries and Wages	\$ 6,069.19
POLICE - Amount of appropriation if ordinance fails	\$68,882.81
POLICE - Amount of appropriation if ordinance is enacted	\$74,952.00


BE IT ALSO ORDAINED, that a certified copy of this ordinance as introduced, be filed with the Director of the Division of Local Government Services within 5 days of introduction, and

BE IT FURTHER ORDAINED, that a certified copy of this ordinance, upon adoption, with the receorded bote included thereon, be filed with said Director within 5 days after such adoption.






