

AN ORDINANCE AUTHORIZING THE MAYOR  
AND MUNICIPAL CLERK OF THE MUNICIPALITY  
OF WINFIELD TO EXECUTE AN AGREEMENT WITH THE  
COUNTY OF UNION TO MODIFY THE INTERLOCAL  
SERVICES AGREEMENT DATED DECEMBER 15, 1974.

WHEREAS, certain Federal funds are potentially available to the County of Union under Title I of the Housing and Community Development Act of 1974, as amended, commonly known as Community Development Block Grants; and

WHEREAS, it is necessary to amend an existing interlocal services agreement for the County and its people to benefit from this program; and

WHEREAS, an agreement has been proposed under which the Municipality of Winfield and the County of Union in cooperation with other municipalities will modify an Interlocal Services Program pursuant to N.J.S.A. 40:8A-1; and

WHEREAS, it is in the best interests of the Municipality of Winfield to enter into such an agreement;

NOW, THEREFORE, be it ordained by the Mayor and Governing Body of the Municipality of Winfield that the agreement entitled "Agreement to Modify Interlocal Services Agreement" dated December 15, 1974, for the Purpose of Inserting a Description of Activities for the 1983 Emergency Jobs Bill Grant, a copy of which is attached hereto, be executed by the Mayor and Municipal Clerk in accordance with the provisions of the law; and

BE IT FURTHER ORDAINED that this ordinance shall take effect immediately upon its enactment.

AGREEMENT TO MODIFY INTERLOCAL SERVICES  
AGREEMENT DATED DECEMBER 15, 1974, AND  
AS AMENDED, FOR THE PURPOSE OF INSERTING  
A DESCRIPTION OF THE ACTIVITIES FOR THE  
1983 UNION COUNTY EMERGENCY JOBS BILL GRANT.

WHEREAS, this contract, the Interlocal Services Agreement, dated December 15, 1974, was entered into by various parties, including the Municipality of Winfield; and

WHEREAS, in order to meet federal requirements there must be a binding agreement in effect; and

WHEREAS, the Interlocal Services Act requires a specific delineation of activities to be included in the Agreement, and it is necessary to amend the said Agreement to insert a description of activities for the 1983 Union County Emergency Jobs Bill Grant.

NOW, THEREFORE, it is mutually agreed that the Interlocal Services Contract dated December 15, 1974 be amended by adding the following Section:

Section C-1 (Emergency Jobs Bill Activities)

1. Nature of Activity.


