

ORDINANCE FIXING SALARIES OF TOWNSHIP CLERK, TOWNSHIP TREASURER,  
TOWNSHIP RECORDER, TAX ASSESSOR AND COLLECTOR, TOWNSHIP  
ATTORNEY, TOWNSHIP COMMITTEEMEN, COURT CLERK, AND  
DIRECTOR OF WELFARE.

All ordinances fixing salaries heretofore passed and adopted by the Township Committee are hereby revised and amended to read as follows:

Be it ordained by the Township Committee of the Township of Winfield, County of Union and State of New Jersey, that the salaries attached to the offices of Township Clerk, Township Treasurer, Township Recorder, Tax Assessor and Collector, Township Attorney and Township Committeemen, Court Clerk and Director of Welfare, shall be and are hereby fixed respectively as follows:

Township Clerk	\$300.00 per annum.
Township Treasurer	\$300.00 per annum.
Township Recorder	\$300.00 per annum.
Tax Assessor and Collector	\$100.00 per annum.
Township Attorney	\$400.00 per annum.
Township Committeemen	\$600.00 per annum.(each)
Court Clerk	\$100.00 per annum.
Director of Welfare	\$500.00 per annum

The salaries fixed by the foregoing section of this ordinance shall be payable at the rates therein fixed in equal monthly installments. Said respective salaries shall be in lieu of any and all fees to which the respective incumbents of said offices might otherwise be entitled by statute or ordinance, which fees shall immediately, upon collection thereof be paid over to the Township Treasurer for the use of the Township.
