

AN ORDINANCE APPROPRIATING \$3,000 FROM THE CAPITAL SURPLUS FUND OF THE TOWNSHIP OF WINFIELD IN THE COUNTY OF UNION, NEW JERSEY, IN ORDER TO PROVIDE FOR IMPROVEMENTS TO THE POLICE COMMUNICATIONS SYSTEM OF THE TOWNSHIP.

BE IT ORDAINED BY THE TOWNSHIP COMMITTEE OF THE TOWNSHIP OF WINFIELD, UNION COUNTY, NEW JERSEY AS FOLLOWS:


SECTION 1. The aggregate amount of \$3,000 is hereby appropriated from the Capital Surplus Fund of the Township of Winfield, New Jersey, for the following capital project of the Township.

Improvements to the Police Communication System including purchase and installation of radio and telephone lines, purchase and installation of communications console at Cranford Police Department, purchase of Motorola Interconnection equipment and mobile scanner .....	\$3,000.00

SECTION 2. The capital budget of the Township of Winfield is hereby amended to conform with the provisions of this Ordinance to the extent of any inconsistency herewith. The resolution in the form promulgated by the Local Finance Board showing full detail of the amended capital budget and capital program as approved by the Director of the Division of Local Government Services is on file with the Clerk and is available for public inspection.

SECTION 3. This Ordinance shall take effect upon final passage and publication as required by law.


