f. Police Dispatcher	January 1, 1984	\$4.50 per hour	Monthly

Section 2. All ordinances or parts of ordinances inconsistent herewith are hereby repealed to the extent of such inconsistency.

Section 3. This ordinance shall take effect immediately following final passage and publication as required by law and shall be effective as of January 1, 1984 or such other later effective date as is specifically provided herein.


