AN ORDINANCE TO PROVIDE FOR THE CONSTRUCTION OF HEALTH FACILITIES, ADDITION TO THE MUNICIPAL BUILDING AND PURCHASE OF EQUIPMENT: AND APPROPRI-ATING \$98,000.00 FOR SAID PURPOSES AND AUTHORIZ-ING THE ISSUANCE OF \$12,000.00 OF BONDS OR NOTES OF THE TOWNSHIP

BE IT ORDAINED by the Township Committee of the Township of Winfield, in the County of Union, New Jersey, as follows:

SECTION 1. The improvements authorized are as follows:

(a) Construction of Health Facilities (b) Addition to Municipal Building	\$65,000.00
and purchase of Equipment	33,000.00
Total	\$98,000.00

SECTION 2.

Financing of said improvements is as follows	:
(a) Section 1 (a) Construction of Health Facilities

(b) Section 1 (b) Addition to Municipal Building and Purchase of Equipment

Total	\$98,000.00

SECTION 3. It is hereby determined that the period of usefullness of the aforesaid improvements, the financing of which the aforesaid obligation are hereby issued, is the period of fifteen years (15), and that the obligations authorized by this Ordinance will be within all debt limitations prescribed by the laws of the State of New Jersey.

SECTION 4. The some of Six Thousand Five Hundred Dollars (\$6,500.00) is stated as the aggregate amount included in the cost of the aforesaid improvement for engineering and inspection costs, cost of authorizing, selling and issuing obligations, legal and including all costs connected with the advertising.

SECTION 5. The bonds and bond anticipation notes authorized to be issued herein shall bear interest at such rate or rates as shall hereafter be determined and shall mature and be paid within the aforesaid period of usefulness in annual installments, the first of which shall be payable not more than one year from the date of the bonds and no annual installment shall exceed by more than one hundred precent (100%) the amount of the smallest prior installment.

SECTION 6. The full faith and credit of the Township of Winfield, New Jersey, are hereby pledged for the payment of the principal and interest on all of the bonds or notes issued pursuant to this Ordinance, and the sums required for such payment shall, in each year while any of said bonds or notes are outstanding, be included in the annual budget and raised by taxes levied upon all the taxable property within said Township without limit as to rate or

SECTION 7. The invalidity or ineffectiveness of any one or more terms or provisions of the foregoing Ordinance, or the inapplicability thereof to any person or circumstances, shall not be deemed to affect the validity and effectiveness of the remaining terms and provisions or the applicability or any terms or provision to other persons and circumstances; but each term and provision shall be deemed to the separate and independent. SECTION 8. All matters relating to the obligations not herein specifically set forth may be determined and provided by subsequent resolutions or as provided by law.

SECTION 9. The Capital Budget of the Township is hereby amended to conform with the provisions of this Ordinance for the extent of any inconsistency herewith and the resolutions promulgated by the local Finance Board showing all detail of the amended Capital Budget and Capital Program as approved by the Director, Division of Local Government Services and are on file with the Township Clerk and are available for public inspection.
