

AN ORDINANCE FIXING SALARIES OF CERTAIN  
OFFICIALS AND EMPLOYEES OF THE TOWNSHIP  
OF WINFIELD FOR 1987

BE IT ORDAINED BY THE TOWNSHIP COMMITTEE OF THE TOWNSHIP OF WINFIELD,  
IN THE COUNTY OF UNION:

SECTION 1: The salaries of all officials and employees of the Township of Winfield, hereinafter designated are hereby established and fixed in the amounts indicated:




SECTION 2: All ordinances or parts of ordinances inconsistent herewith are hereby repealed as to such inconsistent parts or provisions.


#### PUBLIC NOTICE
