

AN ORDINANCE TO AMEND AND SUPPLEMENT ORDINANCE 173 ESTABLISHING A STATE UNIFORM CONSTRUCTION CODE ENFORCING AGENCY, A CONSTRUCTION FEE SCHEDULE, A CONSTRUCTION BOARD OF APPEALS AND FIRE LIMITS, PURSUANT TO CHAPTER 217, LAWS OF NEW JERSEY 1975 AND TITLE 5 CHAPTER 23 OF NEW JERSEY ADMINISTRATIVE CODE.

BE IT ORDAINED by the Township Committee of the Township of Winfield as follows:

Section 1: Section 3a(3) is hereby amended to include the fee schedule as follows:

ROUGH WIRING AND FIXTURES

All switches, lights and receptacles to be counted as outlets.

1 - 10 Outlets	\$10.00
11 - 50 Outlets	20.00
51 - 100 Outlets	30.00
Each additional 50 or fraction of	10.00

FEEDERS, SERVICE, METER EQUIPMENT

100 amp or smaller	10.00
101 amp - 500 amp	20.00
501 amp - 1000 amp	35.00
1001 amp or larger	50.00

HEATING, COOLING, COOKING, SIGNS, MOTORS, GENERATORS, TRANSFORMERS, ELECTRIC FURNACES, WELDERS, ETC.

Single unit or group not exceeding 5 motors up to 1 H.P., K.W. or K.V.A.	10.00
All units 1 H.P. to 25 H.P., K.W. or K.V.A. each	5.00
Over 25 H.P. to 100 H.P., K.W. or K.V.A. each	10.00
Over 100 H.P., K.W. or K.V.A. each	15.00

POOLS, FOUNTAINS AND SIMILAR INSTALLATIONS

Above Ground	20.00
Below Ground	35.00


One family dwelling	20.00
Two Family Dwelling	35.00
Three family dwelling or larger per unit	15.00
All other structures	25.00

REINSPECTION OR REINTRODUCTION OF CURRENT Charge in relation to amount of supervision but not less than 20.00

ISSUANCE OF DUPLICATE CERTIFICATE 2.00

SPECIAL SERVICE AND/OR CONDITIONS NOT PROVIDED FOR IN THE ABOVE LISTED FEES, SHALL BE APPLIED FOR AND SHALL BE PAID AS SET FORTH BY THE CONSTRUCTION CODE DEPARTMENT.

Section 2: This ordinance shall take effect June 1, 1987.
