



(5). Section 5 of Ordinance # 247 is amended to read as follows:


Section 5: Additional methods of disposal.

Any resident may donate or sell (used newspapers, glass, aluminum cans, and yard waste) to any person, partnership or corporation whether operating for profit or not for profit. Said person, partnership or corporation may not, however, under any circumstances pick up said (used newspapers, glass, aluminum cans, or yard waste) from the curbside in the Township of Winfield.

These amendments shall take effect upon publication and final passage in a manner prescribed by law.



AN ORDINANCE TO AMEND AND SUPPLEMENT WINFIELD ORDINANCE #247

AN ORDINANCE ESTABLISHING IN THE TOWNSHIP OF WINFIELD A MANDATORY PROGRAM FOR THE SEPARATION OF (USED NEWSPAPERS, GLASS, ALUMINUM CANS, AND YARD WASTE) FROM HOUSEHOLD SOLID WASTE, THE COLLECTION OF SUCH (USED NEWSPAPERS, GLASS, ALUMINUM CANS, AND YARD WASTE) FROM RESIDENCES FOR RECYCLING PURPOSES, PROMULGATING RULES AND REGULATIONS THEREFORE, AND PRESCRIBING PENALTIES FOR THE VIOLATION THEREOF.

BE IT ORDAINED by the Governing Body of the Township of Winfield that:

(1). Section 1 of Ordinance # 247 is amended to read as follows:

Section 1: Collection program established:

There is hereby established a program for the separate collection of (used newspapers, glass, aluminum cans, and yard waste) from the residences of the Township of Winfield for recycling purposes. Such collections shall be made (twice monthly) under the supervision of the Municipal Recycling Coordinator, under the direction of the Superintendent of Public Works.

(2). Section 2 of Ordinance # 247 is amended to read as follows:

Section 2: Regulations Authorized:

Said Coordinator is hereby authorized and directed to establish and promulgate regulations as to the manner, days and times of such collections and the bundling, handling, location and time of placement of all materials for collection, with the prior approval of the Township Committee.

(3). Section 3 of Ordinance # 247 is amended to read as follows:

Section 3: Separation of (used newspapers, glass, aluminum cans, and yard waste):

(Uncontaminated newspapers, glass, aluminum cans, and yard waste) shall be kept separate from and not mixed with trash and household solid waste. (Used newspapers, glass, aluminum cans, and yard waste) shall be considered clean and uncontaminated if they have not been exposed to substances or conditions rendering them unusable for recycling.

(4). Section 4 of Ordinance # 247 is amended to read as follows:

Section 4: Ownership of (used newspapers, glass, aluminum cans, and yard waste:

From the time of placement at the curb by any resident of (used newspapers, glass, aluminum cans, and yard waste) for collection by the Township of Winfield or its authorized agent pursuant to the program established hereby and the rules and regulations issued hereunder, such materials shall become and be the property of the Township of Winfield and it shall be a violation of this Ordinance for any person other than authorized personnel of the Township of Winfield or the contributing resident to collect, pick up, or cause to be collected or picked up, such materials. Each such collection in violation hereof from one or more residences during said period shall constitute a separate and distinct offense.
