

ORDINANCE AUTHORIZING THE MAYOR AND MUNICIPAL CLERK
TO AMEND AN AGREEMENT WITH UNION COUNTY TO MODIFY THE
INTERLOCAL SERVICES AGREEMENT DATED DECEMBER 15, 1974

WHEREAS, certain Federal Funds are potentially available to Union County under Title I of the Housing and Community Development Act of 1974, commonly known as Community Development Block Grants, and

WHEREAS, the U.S. Department of Housing and Urban Development requires an Amendment in the existing interlocal agreements for the county, its participant municipalities, and its people to benefit from this program, and

WHEREAS, an Agreement has been proposed under which the Township of Winfield and the County of Union in cooperation with participant municipalities will modify the Interlocal Services contract pursuant to N.J.S. 40:8A-1, and


WHEREAS, it is in the best interest of the Township of Winfield to enter into such an agreement,

AGREEMENT TO MODIFY INTERLOCAL SERVICES AGREEMENT DATED
DECEMBER 15, 1974, AND AS AMENDED, FOR THE PURPOSE
OF INSERTING A DESCRIPTION OF ACTIVITIES FOR THE THIRTEENTH
YEAR UNION COUNTY COMMUNITY DEVELOPMENT BLOCK GRANT PROGRAM

WHEREAS, this contract, the Interlocal Services Agreement, dated December 15, 1974, was entered into by various parties, including the Municipality of the Township of Winfield; and

WHEREAS, in order to meet federal requirements there must be a binding agreement in effect; and

WHEREAS, the Interlocal Services Act requires a specific delineation of activities to be included in the Agreement, and it is necessary to amend the said Agreement to insert a description of activities for Year Thirteen Urban County Community Development Block Grant Program;

NOW, THEREFORE, it is mutually agreed that the Interlocal Services Contract dated December 15, 1974 be amended by adding the following section:

Section C-1 (Thirteenth Year Actiities)
