

AN ORDINANCE TO PROVIDE FOR THE RESURFACING
OF RIVERVIEW TERRACE IN THE TOWNSHIP OF WINFIELD,
MAKING AN APPROPRIATION THEREFORE AND
AUTHORIZING THE FINANCING THEREOF.

BE IT ORDAINED by the Township Committee of Township of Winfield, as follows:

SECTION 1. Riverview Terrace from Wavecrest Avenue to South Pass shall be improved by resurfacing.

SECTION 2. The estimated cost of the resurfacing is Thirty Thousand Five Hundred Dollars (\$30,500.00).

SECTION 3. The said improvement shall be constructed as a general improvement and the cost thereof shall be borne by the Township of Winfield at large. Said improvement shall be according to plans, specifications and profiles for said work prepared by the Township Engineer and on file in his office, and the same shall be done under the supervision of the Township Engineer.

SECTION 4. There is hereby appropriated, in addition to the obligations hereby authorized, the sum of One Thousand Five Hundred Dollars, (\$1,500.00), which sum has been made available in the capital improvement fund in a previously adopted budget of the Township of Winfield as a down payment. Said sum not being less than five percent (5%) of the obligations authorized herein. In addition, there shall be appropriated for the purpose aforesaid the amount of Twenty-Nine Thousand Dollars (\$29,000.00) to be made available to the Township of Winfield by the 1984 New Jersey Transportation Trust Fund Authority Act.

SECTION 5. It is hereby determined that the period of usefulness of the aforesaid improvements, the financing of which the aforesaid obligations are hereby issued, is the period of fifteen (15) years, and that the obligations authorized by this Ordinance will be within all debt limitations prescribed by the laws of the State of New Jersey.

SECTION 6. The sum of Three Thousand Dollars (\$3,000.00) is stated as the aggregate amount included in the cost of the aforesaid improvement for engineering and inspection costs, legal and including all costs connected with the advertising.

SECTION 7. The invalidity or ineffectiveness of any one or more terms or provisions of the foregoing Ordinance, or the inapplicability thereof to any person or circumstances, shall not be deemed to affect the validity and effectiveness of the remaining terms and provisions or the applicability of any term or provision to other persons and circumstances; but each term and provision shall be deemed to be separate and independent.

SECTION 8. All matters relating to the obligations not herein specifically set forth may be determined and provided by subsequent resolutions or as provided by law.

SECTION 9. This Ordinance shall take effect in the manner prescribed by law.


N O T I C E
