

SECTION 2: All ordinances or parts of ordinances inconsistent herewith are hereby repealed as to such inconsistent parts or provisions.


SECTION 3: This ordinance shall take effect immediately following final passage and publications as required by law and shall be effective beginning as of January 1, 1988




PUBLIC NOTICE
