AGREEMENT DATED DECEMBER 15, 1974

WHEREAS, certain Federal funds are potentially available to the County of Union under Title I of the Housing and Community Development Act of 1974, as amended, commonly known as Community Development Block Grants; and

WHEREAS, it is necessary to amend an existing interlocal services agreement for the County and its people to benefit from this program; and

WHEREAS, an agreement has been proposed under which the Township of Winfield and the County of Union in cooperation with other municipalities will modify an Interlocal Services Program pursuant to N.J.S.A. 40:8A-1; and

WHEREAS, it is in the best interests of the Township of Winfield to enter into such an agreement;

NOW THEREFORE, be it ordained by the Mayor and Governing Body of the Township of Winfield that the agreement entitled "Agreement to Modify Interlocal Services Agreement Dated December 14, 1974, for the Purpose of Inserting a Description of Activities for the Fifteenth Year Union County Community Development Block Grant Program," a copy of which is attached hereto, be executed by the Mayor and Municipal Clerk in accordance with the provisions of law; and

BE IT FURTHER ORDAINED that this ordinance shall take effect immediately upon its enactment.
