

**AN ORDINANCE TO PROVIDE FOR THE RESURFACING
OF SEAFOAM AVENUE FROM RIVERVIEW TERRACE TO VELTHOVEN TERRACE
IN THE TOWNSHIP OF WINFIELD, MAKING AN APPROPRIATION THEREOF
AND AUTHORIZING THE FINANCING THEREOF**

BE IT ORDAINED, by the Township Committee of the Township of Winfield, as follows:

SECTION 1. Seafoam Avenue from Riverview Terrace to Velthoven Terrace shall be improved by resurfacing.

SECTION 2. The estimated cost of the resurfacing is Thirty Seven Thousand Dollars (\$37,500.00).

SECTION 3. The said improvement shall be constructed as a general improvement and the cost thereof shall be borne by the Township of Winfield at large. Said improvement shall be according to plans, specifications and profiles for said work prepared by the Township Engineer and on file in his office, and the same shall be done under the supervision of the Township Engineer.

SECTION 4. There is hereby appropriated, in addition to the obligations hereby authorized, the sum of Five Hundred Dollars, (\$500.00), which sum has been made available in the capital improvement fund in a previously adopted budget of the Township of Winfield as a down payment. In addition, there shall be appropriated for the purpose aforesaid the amount of Thirty Seven Thousand Dollars (\$37,000.00) to be made available to the Township of Winfield by the New Jersey Transportation Trust Fund Authority Act for Fiscal Year 1989.


SECTION 5. It is hereby determined that the period of usefulness of the aforesaid improvements, the financing of which the aforesaid obligations are hereby issued, is the period of fifteen (15) years, and that the obligations authorized by this Ordinance will be within all debt limitations prescribed by the laws of the State of New Jersey.

SECTION 6. The sum of \$3,000.00) is stated as the aggregate amount included in the cost of the aforesaid improvement for engineering and inspection costs, legal and including all costs connected with the advertising.


SECTION 7. The invalidity or ineffectiveness of any one or more terms or provisions of the foregoing Ordinance, or the inapplicability thereof to any person or circumstances, shall not be deemed to affect the validity and effectiveness of the remaining terms and provisions or the applicability of any term or provision to other persons and circumstances; but each term and provision shall be deemed to be separate and independent.

SECTION 8. All matters relating to the obligations not herein specifically set forth may be determined and provided by subsequent resolutions or as provided by law.


SECTION 9. This Ordinance shall take effect in the manner prescribed by law.




