

**AN ORDINANCE FIXING SALARIES OF CERTAIN OFFICIALS AND EMPLOYEES
OF THE TOWNSHIP OF WINFIELD FOR 1990**

BE IT ORDAINED BY THE TOWNSHIP COMMITTEE OF THE TOWNSHIP OF WINFIELD, COUNTY OF UNION:
