

**AN ORDINANCE FIXING SALARIES OF CERTAIN OFFICIALS AND EMPLOYEES  
OF THE TOWNSHIP OF WINFIELD FOR 1991**

**BE IT ORDAINED BY THE TOWNSHIP COMMITTEE OF THE TOWNSHIP OF WINFIELD, COUNTY OF UNION:**




**SECTION 2:** All ordinances or parts of ordinances inconsistent herewith are hereby repealed as to such inconsistent parts or provisions.


