AN ORDINANCE TO AMEND AN ORDINANCE ENTITIED: "AN ORDINANCE ESTABLISHING THE OFFICE OF TOWNSHIP ATTORNEY FOR THE TOWNSHIP OF WINFIELD, DEFINING THE DUTIES OF SAME AND FIXING THE SALARY OF THE OFFICE", APPROVED JULY 26, 1943 AS AMENDED AND SUPPLEMENTED.

BE IT ORDAINED by the Township Committee of the Township of Winfield, Union County, New Jersey:

SECTION ONE: That the ordinance entitled, "An Ordinance establishing the office of Township Attorney for the Township of Winfield, defining the duties of same and fixing the salary of the office", approved July 26, 1943 as amended and supplemented, shall be and the same is hereby further amended to provide as follows:

SECTION TWO: The Township Attorney shall attend all meetings of the Township Committee when called upon. He shall advise the Township Committee and the officers of the Township on all matters which may be submitted to him for his opinion. He shall draw such ordinances and resolutions as may be required of him by the Township Committee. He shall prepare leases, obligations, bonds, contracts, attend Budget Hearings, and prepare other legal instruments relating to the business of the Township, and shall prosecute and defend as counsel for the Township, and all actions which may be brought by or against it or any officers thereof, or by reason of any matter or duty connected with or growing out of the respective offices or in which the Township is interested in any court of this State whenever thereunto requested by the Township Committee.

SECTION THREE: The Township Attorney shall receive a salary of SEVEN HUNDRED DOLLARS (\$700.00) per year, payable in equal quarterly installments for the services hereinabove mentioned and he shall be further permitted a supplemental amount upon approval by the Township Committee from the Township funds for such services as shall be rendered in the litigation of matters involving the Township, its officers or employees, when so directed by the Township Committee when such services shall involve expenditures for cost and expenses in preparation for trial.

SECTION FOUR: All ordinances or parts of ordinances inconsistent herewith are hereby repealed.

SECTION FIVE: This ordinance shall take effect as of January 1st, 1948.
