AGREEMENT TO MODIFY INTERLOCAL SERVICES AGREEMENT DATED DECEMBER 14, 1974, AND AS AMENDED, FOR THE PURPOSE OF INSERTING A DESCRIPTION OF ACTIVITIES FOR THE EIGHTEENTH YEAR UNION COUNTY COMMUNITY DEVELOPMENT BLOCK GRANT PROGRAM
