

AN ORDINANCE AUTHORIZING THE MAYOR AND THE MUNICIPAL CLERK
OF THE TOWNSHIP OF WINFIELD TO EXECUTE AN AGREEMENT WITH
THE COUNTY OF UNION TO MODIFY THE INTERLOCAL SERVICES
AGREEMENT DATED DECEMBER 15, 1974

WHEREAS, certain Federal funds are potentially available to the County of Union under Title I of the Housing and Community Development Act of 1974, as amended, commonly known as Community Development Block Grants; and


WHEREAS, it is necessary to amend an existing interlocal services agreement for the County and its people to benefit from this program; and

WHEREAS, an agreement has been proposed under which the Township of Winfield and the County of Union in cooperation with other municipalities will modify an Interlocal Services Program pursuant to N.J.S.A. 40:8A-1; and

WHEREAS, it is in the best interests of the Township of Winfield to enter into such an agreement;

NOW THEREFORE, be it ordained by the Mayor and Governing Body of the Township of Winfield that the agreement entitled "Agreement to Modify Interlocal Services Agreement Dated December 14, 1974, for the Purpose of Inserting a Description of Activities for the Nineteenth Year Union County Community Development Block Grant Program," a copy of which is attached hereto, be executed by the Mayor and Municipal Clerk in accordance with the provisions of law; and

BE IT FURTHER ORDAINED that this ordinance shall take effect immediately upon its enactment.




PUBLIC NOTICE

AGREEMENT TO MODIFY INTERLOCAL SERVICES AGREEMENT DATED DECEMBER 14, 1974, AND AS AMENDED, FOR THE PURPOSE OF INSERTING A DESCRIPTION OF ACTIVITIES FOR THE NINETEENTH YEAR UNION COUNTY COMMUNITY DEVELOPMENT BLOCK GRANT PROGRAM

WHEREAS, this contract, the Interlocal Services Agreement, dated December 15, 1974, was entered into by various parties, including the Township of Winfield; and

WHEREAS, in order to meet federal requirements there must be a binding agreement in effect; and

WHEREAS, the Interlocal Services Act requires a specific delineation of activities to be included in the Agreement, and it is necessary to amend the said Agreement to insert a description of activities for Year Nineteenth Union County Development Block Grant Program;

NOW, THEREFORE, it is mutually agreed that the Interlocal Services Contract dated December 15, 1974 be amended by adding the following Section:

Section C-1 (Nineteenth Year Activities)

1. Nature of Activity.

See Nineteenth Year Application dated June 4, 1993 prepared by the County of Union, and attached hereto and made a part hereof.
