

**AN ORDINANCE TO AMEND AN ORDINANCE GRANTING A  
NON-EXCLUSIVE FRANCHISE TO SUBURBAN CABLEVISION, A  
CORPORATION OF NEW JERSEY, TO CONSTRUCT, CONNECT, OPERATE  
AND MAINTAIN A CABLE TELEVISION SYSTEM IN THE  
TOWNSHIP OF WINFIELD, UNION COUNTY, NEW JERSEY**

NOW, THEREFORE, BE IT ORDAINED by the Township Committee of the Township of Winfield that the Ordinance providing a Non-Exclusive Franchise to Suburban Cablevision is hereby amended and supplemented as follows:

**Section 1.** Section IV. "Duration of Franchise" is hereby amended to provide that the duration of consent granted therein shall expire ten (10) years from the effective date of this amended ordinance.

**Section 2.** Section XVI. "Liability Insurance" is hereby amended to provide that company shall at all times maintain a comprehensive general liability insurance with a single occurrence limit amount of One Million (\$1,000,000.00) Dollars covering liability arising out of its construction and operation of the cable television system and excess liability insurance in the amount of \$10,000,000.00. The Township of Winfield shall be named as an additional insured under said policy.

**Section 3.** The remaining sections of this ordinance are not effected by this Amended Ordinance and shall remain in force and effect and are incorporated herein by reference and made a part hereof.

**Section 4.** Any Ordinance or parts of ordinances inconsistent herewith are hereby repealed as to such inconsistencies only.

**Section 5.** In the event any portion of this ordinance is determined to be invalid, that determination shall not effect the remaining sections of this Amended Ordinance.

**Section 6.** This ordinance shall take effect immediately upon receipt by the municipality or written confirmation that the company accepts the terms and conditions herein and upon adoption and publication according to law.


**Section 7.** This municipal consent shall become effective as of the date upon which the municipality receives written notification that the company accepts the terms and conditions herein and upon final hearing and publication according to law.

The consent herein granted shall be subject to review after completion of the initial five (5) years of the term. Suburban Cablevision shall write to the Township, attention Township Clerk, advising the Township of the Township's right of review of its performance under this Ordinance and shall present such reasonable and appropriate information as the Township may request. Any review process shall be completed within six (6) months of the initiating letter submitted by Suburban Cablevision. Upon expiration of the (6) month period without a determination by the full Township Committee that the municipal consent should be revoked, the municipal consent shall continue in full force and effect for the remaining five (5) year term.

Any determination by the Township Committee to revoke municipal consent shall occur only after full public hearing on reasonable notice to Suburban Cablevision providing Suburban Cablevision with a full opportunity to present itself to the Township Committee and respond to any asserted failure to comply with the terms of the Ordinance and only upon a formal finding of substantial and material non-compliance with the terms of the Ordinance. Any such finding shall contain a full statement of reasons for revocation. Any such revocation determination of the Township Committee shall be forwarded to the State Office of Cable Television for proceedings in accordance with State Law.

**Section 8. Section XXII. Effective Date of this Ordinance.**  
This amended Ordinance shall become effective as of the date upon which the municipality receives written notification that the company accepts the terms and conditions herein including commitments to the Board of Education to provide a 25" television and VCR equipment, and upon final hearing and publication according to law.


