

**TOWNSHIP OF WINFIELD
AN ORDINANCE AUTHORIZING THE MAYOR AND TOWNSHIP CLERK
OF THE TOWNSHIP OF WINFIELD TO EXECUTE AN
AGREEMENT WITH THE COUNTY OF UNION TO MODIFY THE INTERLOCAL
SERVICES AGREEMENT DATED DECEMBER 15, 1974 AND AS AMENDED**

WHEREAS, certain Federal Funds are potentially available to the County of Union under Title I of the Housing and Community Development Act of 1975, as amended, commonly known as Community Development Block Grants, and

WHEREAS, certain Federal funds are potentially available to County of Union under Title II of the National Affordable Housing Act of 1990, commonly known as HOME Investment Partnerships Program; and

WHEREAS, it is necessary to amend an existing interlocal services agreement for the County and its people to benefit from this program; and


WHEREAS, an agreement has been proposed under which the Township of Winfield and the County of Union in cooperation with other Municipalities will modify an Interlocal Services Program pursuant to N.J.S.A. 40:8A-1; and

WHEREAS, it is in the best interests of the Township of Winfield to enter into such an agreement;

NOW, THEREFORE, be it ordained by the Mayor and the Governing Body of the Township of Winfield that the agreement entitled "Agreement to Modify Interlocal Services Agreement dated December 14, 1974, for the Purpose of Inserting a Description of Activities for the "Twenty-first Year Union County Community Development Block Grant Program " a copy of which is attached hereto, and the Fourth Year of the HOME Investment Partnerships Program, a copy of which is also attached hereto, be executed by the Mayor and Township Clerk in accordance with the provisions of law; and

BE IT FURTHER ORDAINED that this ordinance shall take effect immediately upon its enactment.

**AGREEMENT TO MODIFY INTERLOCAL SERVICES AGREEMENT
DATED DECEMBER 15, 1974. AND AS AMENDED, FOR THE PURPOSE OF
A DESCRIPTION OF ACTIVITIES FOR THE TWENTY-FIRST YEAR
UNION COUNTY COMMUNITY DEVELOPMENT BLOCK GRANT PROGRAM AND THE
FOURTH YEAR OF THE HOME INVESTMENT PARTNERSHIPS PROGRAM**

WHEREAS, this contract, the Interlocal Services Agreement, dated December 15, 1974, was entered into by various parties, including the Township of Winfield; and

WHEREAS, in order to meet federal requirements there must be a binding agreement in effect; and

WHEREAS, the interlocal Services Act requires a specific delineation of activities to be included in the Agreement, and it is necessary to amend the said Agreement to insert a description of activities for the Twenty-First Year Union County Community Development Block Grant Program and the Fourth Year of the HOME Investment Partnerships Program;

NOW THEREFORE, it is mutually agreed that the Interlocal Services Contract dated December 15, 1974 be amended by adding the following Section:

Section D-1 (Agreement as to Specific Activities)

1. Contained in the Action Plan of the 1995 Union County Consortium Consolidated Plan.
