

## TOWNSHIP OF WINFIELD

**AN ORDINANCE TO AMEND ORDINANCE 124 REGARDING THE

PORTABLE AND WADING POOLS, THE ISSUANCE OF  
PERMITS AND REGISTRATION, TOGETHER WITH  
PENALTIES FOR THE VIOLATIONS THEREOF,  
IN THE TOWNSHIP OF WINFIELD, NEW JERSEY**


**BE IT ORDAINED** by the Township Committee of the Township of Winfield that Ordinance 124 is hereby amended as follows:

Section 1.           Section 9. Enclosure


Every pool, other than a wading pool, shall be erected in conformance with the New Jersey Uniform Construction Code, and shall be completely enclosed by a good quality, sturdy fence. Every gate or other opening in the fence enclosing such pool shall be kept closed and shall utilize an approved security device at all times when the owner or occupant of the premises is not present at such pool. Ladders, if used in conjunction with the pool, shall be removed when the pool is not in use.


Section 2.           An inspection fee of \$10.00 shall be charged by the Board of Health in enforcing this Ordinance.

Section 3.           All ordinances or parts of ordinances in consistent herewith be and the same are hereby repealed. This Ordinance shall take effect immediately after final passage and publication according to law.
