

TOWNSHIP OF WINFIELD – TO 385 UNION COUNTY, STATE OF NEW JERSEY

AN ORDINANCE TO AMEND ORDINANCE # 363, AN ORDINANCE TO PROVIDE FOR THE PURCHASE OF COMPUTER EQUIPMENT FOR VARIOUS DEPARTMENTS AND TO PROVIDE FOR ENGINEERING SERVICES FOR THE SEWER REHABILITATION PROJECT AND THE RECONSTRUCTION OF THE SENIOR CITIZENS PARKING LOT DRAIN

BE IT ORDAINED by the Township Committee of the Township of Winfield in the County of Union, New Jersey, the Ordinance # 363, entitled, "AN ORDINANCE TO PROVIDE FOR THE PURCHASE OF COMPUTER EQUIPMENT FOR VARIOUS DEPARTMENTS AND TO PROVIDE FOR ENGINEERING SERVICES FOR THE SEWER REHABILITATION PROJECT AND THE RECONSTRUCTION OF THE SENIOR CITIZENS PARKING LOT DRAIN", be amended as follows:

SECTION 1. The Township be authorized to purchase a Digital Recording System to be shared by the Municipal Court and Municipal Clerk's office, to provide for the reconditioning of the basketball courts at the Winfield Township School, to provide for renovations and furnishings to the municipal building and repairs to the Firehouse bay doors.

SECTION 2. The estimated cost of the aforementioned project is Fifteen Thousand Dollars (\$15,000.00) for the purchase of computers and the digital recording system, Two Thousand Five Dollars (\$2,500.00) for reconditioning the basketball courts at the Winfield Township School and Five Thousand Dollars (\$5,000.00) for renovations and furnishings to the municipal building.

SECTION 4. There is hereby appropriated the additional sum of Eight Thousand Dollars (\$8,000.00), which supplements the Twenty Thousand Seven Hundred Dollars (\$20,700.00), previously appropriated by Ordinance #363 and the Seven Thousand Five Hundred Dollars appropriated by Ordinance #365 Amending Ordinance #363 of which sum \$8,000.00 has been made available in the Capital Fund of the current budget of the Township of Winfield.

SECTION 9. The Capital Budget of the Township of Winfield is hereby amended to conform with the provisions of this Ordinance for the extent of any inconsistency herewith and the resolutions promulgated by the Local Finance Board showing all detail of the amended Capital Budget Program as approved by the Director, Division of Local Government Services and are on file with the Township Clerk and are for public inspection.

SECTION 10. This Ordinance shall take effect in the manner prescribed by law.
