

## **TOWNSHIP OF WINFIELD - 388**

AN ORDINANCE TO PROVIDE FOR THE RESURFACING OF ATLANTIC DRIVE, PACIFIC DRIVE, SPRAY TERRACE, RIVERVIEW TERRCE, JOHN VELTHOVEN TERRACE AND BOB WILSON PLACE IN THE TOWNSHIP OF WINFIELD, MAKING AN APPROPRIATION AND AUTHORIZING THE FINANCING THEREOF

**BE IT ORDAINED** by the Township Committee of the Township of Winfield in the County of Union, New Jersey, as follows:

**SECTION 1** Atlantic Drive from Seafoam Avenue to Wavecrest Avenue, Pacific Drive from Seafoam Avenue to Wavecrest Avenue, Riverview Terrace from Wavecrest Avenue to County Road, Spray Terrace from Wavecrest Avenue to its terminus, John Velthoven Terrace from Seafoam Avenue to County Road and Bob Wilson from Wavecrest Avenue to County Road shall be improved by resurfacing.

**SECTION 2.** The estimated cost to the Township of Winfield for the aforementioned project is One Hundred Fifty-five Thousand Dollars (\$155,000).

**SECTION 3.** The said improvement shall be considered a general improvement and the cost thereof shall be borne by the Township of Winfield at large. Said improvement shall be according to plans, specifications and profiles for said work prepared by the township engineer and on file with the municipal clerk, and the same shall be done under the supervision of the township engineer.

**SECTION 4.** There is hereby appropriated the sum of One Hundred fifty-five Thousand Dollars (\$155,000) made available to the Township of Winfield by the New Jersey Transportation Trust Fund Authority Act.

**SECTION 5.** It is hereby determined that the period of usefulness of the aforesaid improvement, the financing of which the aforesaid obligations are hereby issued, is the period of five years (5), and that the obligations authorized by this Ordinance will be within all debt limitations prescribed by the laws of the State of New Jersey.

**SECTION 6.** The full faith and credit of the Township of Winfield, New Jersey, are hereby pledged for the payment of the principal interest on all of the bonds or notes issued pursuant to this ordinance, and the sums required for such payment shall, in each year while said bonds or notes are outstanding, be included in the annual budget and raised by taxes levied upon all taxable property within said Township without limits to rate or amount.

**SECTION 7.** The invalidity or ineffectiveness of any one or more terms or provisions of the foregoing Ordinance, or the inapplicability thereof to any person or circumstances, shall not be deemed to affect the validity and effectiveness of the remaining terms and provisions or the applicability or any terms or provisions to other persons and circumstances; each term and provision shall be deemed to be separate and independent.

**SECTION 8.** All matters relating to the obligations not herein specifically set forth be determined and provided by subsequent resolutions or as provided by law.

**SECTION 9.** The Capital Budget of the Township of Winfield is hereby amended to conform with the provisions of this Ordinance for the extent of any inconsistency herewith and the resolutions promulgated by the Local Finance Board showing all detail of the amended Capital Budget Program as approved by the Director, Division of Local Government Services and are on file with the Township Clerk and are for public inspection.

**SECTION** 10. This Ordinance shall take effect in the manner prescribed by law.
