

TOWNSHIP OF WINFIELD - 394 AN ORDINANCE TO ESTABLISH BUS STOPS WITHIN THE TOWNSHIP OF WINFIELD

Be it ordained by the Township Committee of the Township of Winfield,

Section 1: That Pursuant to N.J.S.A. 39:4-8(e), the following described locations are hereby designated as Bus Stops within the Township of Winfield.

1. Wavecrest Avenue:

Street Address	Nearest Cross Street				
2 – 4	corner Seafoam Ave.				
34 – 36	Spray Terrace				
88 – 90	Bob Wilson Place				
118 - 120	Riverview Terrace				

2. Seafoam Avenue:

Street Address	Nearest Cross Street					
29 – 31	John Velthoven Terrace					

Section 2: That the Township Committee of the Township of Winfield will enforce the needed traffic regulations governing the aforementioned bus stop location.

Section 3: All existing ordinances relative to established Bus Stops are hereby repealed.

Section 4: All ordinances or parts of ordinances inconsistent with the provisions of this ordinance to the extent of the inconsistency are repealed.

Section 5: this ordinance shall take effect upon approval of the Commissioner of Transportation as provided by law.
