**Be it ordained by the Township Committee of the Township of Winfield, County of Union:**

**SECTION 1:** The salaries of all officials and employees of the Township of Winfield, hereinafter designated are hereby established and fixed in the amounts indicated;

6. Tax Assessor - \$3,120.00 per annum, payable quarterly
7. Tax Collector - \$811.00 per annum, payable annually
8. Municipal Judge - \$10,010.00 per annum, payable biweekly
9. Court Administrator - \$11,162.00 per annum, payable biweekly
10. Deputy Court Administrator - \$9,734.00 per annum, payable biweekly
11. Municipal Prosecutor - \$3,047.00 per annum, payable quarterly
12. Building Sub-Code Official - \$2,303.00 per annum, payable quarterly

**SECTION 3:** This Ordinance shall take effect immediately following final passage and publications as required by law and shall be effective beginning as of January 1, 2009.





