

TOWNSHIP OF WINFIELD - #406 COUNTY OF UNION, STATE OF NEW JERSEY AN ORDINANCE TO AMEND ORDINANCE #405 AUTHORIZING WATERPROOFING THE BASEMENT AND REPAIRS TO THE ROOF OF THE MUNICIPAL HEADQUARTERS

BE IT ORDAINED by the Township Committee of the Township of Winfield in the County of Union, New Jersey, the Ordinance #405, entitled, "AN ORDINANCE TO AUTHORIZE WATER PROOFING THE BASEMENT AND REPAIRS TO THE ROOF OF THE MUNICIPAL HEADQUARTERS", be amended as follows;

SECTION 2. The estimated cost of the aforementioned projects is amended from Thirteen Thousand Dollars (\$13,000.00) to Eighteen Thousand Dollars (\$18,000.00) for waterproofing the basement, and from Seventeen Thousand Dollars (\$17,000.00) to Thirteen Thousand (\$13,000.00) for repairs to the roof of the municipal headquarters.

SECTION 4. There is hereby appropriated the additional sum of One Thousand Dollars(\$1000.00), which supplements the Thirty Thousand (\$30,000.00) previously appropriated in Ordinance #405, to amend the Ordinance total to Thirty-One Thousand Dollars (\$31,000.00), of which sum \$31,000.00 has been made available in the Capital Improvement Fund of a previously adopted budget of the Township of Winfield.

SECTION 10. This Ordinance shall take effect in the manner prescribed by law.
