6. Tax Collector - \$867.00per annum, payable annually
7. Municipal Judge - \$10,516.00 per annum, payable biweekly
8. Court Administrator - \$12,321.00 per annum, payable biweekly
9. Deputy Court Administrator - \$10,745.00 per annum, payable biweekly
10. Municipal Prosecutor - \$3,202.00 per annum, payable quarterly
11. Building Sub-Code Official - \$2,469.00 per annum, payable quarterly
12. Mechanical Inspector - \$651.00 Annum, payable quarterly
13. Electrical Sub-Code Official - \$1,471.00 per annum, payable quarterly
14. Fire Sub-Code Official - \$635.00 per annum, payable annually



SECTION 2: All ordinances or parts of ordinances inconsistent herewith are hereby repealed as to such inconsistent parts or provisions.


