**Be it ordained by the Township Committee of the Township of Winfield, County of Union:**

**SECTION 1:** The salaries of all officials and employees of the Township of Winfield, hereinafter designated are hereby established and fixed in the amounts indicated;

7. Tax Assessor - \$3,000.00 per annum, payable quarterly
8. Tax Collector - \$800.00 per annum, payable annually
9. Municipal Judge - \$10,516.00 per annum, payable biweekly
10. Court Administrator - \$15,500.00 per annum, payable biweekly
11. Deputy Court Administrator - \$10,745.00 per annum, payable biweekly
12. Deputy Court Administrator - \$23.00 per hr., payable biweekly
13. Municipal Prosecutor - \$3,202.00 per annum, payable quarterly
14. Building Sub-Code Official - \$2,505.00 per annum, payable quarterly
15. Mechanical Inspector - \$660.00 Annum, payable quarterly
16. Electrical Sub-Code Official - \$1,495.00 per annum, payable quarterly
17. Fire Sub-Code Official - \$645.00 per annum, payable annually
18. Plumbing Sub-Code Official - \$880.00 per annum, payable annually
