



**TOWNSHIP OF WINFIELD – ORDINANCE # 430 AMENDING  
AN ORDINANCE # 427 TO PROVIDE FOR THE RESURFACING OF GULFSTREAM  
AVE., WAVECREST AVE. PHASE I AND WINFIELD PLACE AND REPAIR OF POT  
HOLES ON VARIOUS STREETS IN THE TOWNSHIP OF WINFIELD, MAKING AN  
APPROPRIATION AND AUTHORIZING THE FINANCING THEREOF**

**BE IT ORDAINED** by the Township Committee of the Township of Winfield in the County of Union, New Jersey, as follows:

**SECTION 1** Gulfstream Ave., Wavecrest Ave. Phase I and Winfield Place shall be improved by resurfacing; and various streets in the Township will have Pot Holes repaired

**SECTION 2.** The estimated cost to the Township of Winfield for the aforementioned project is Two Hundred Fifty Five Thousand Dollars. (\$255,000.00

**SECTION 4.** There is hereby appropriated the sum of One Hundred Eighty Thousand Dollars (\$180,000.00) made available to the Township of Winfield by the New Jersey Transportation Trust Fund Authority Act and the sum of Fifty Thousand Dollars (\$50,000.00) made available by the 2016 Union County Infrastructure Grant and the sum of Twenty Five Thousand Dollars (\$25,000.00) which has been made available in the Capital Improvement Fund in a previously adopted budget.
